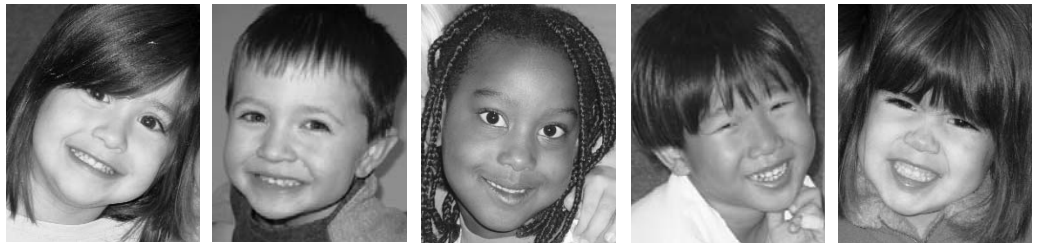

The YMCA is connected through the skyway system and has a three car pick up/drop off lane. Working parents can take advantage of the car pool lanes and spend more time with their child each day by choosing child care close to work. Parents can stop in to visit their child during the day, share lunch time together, or observe them during swim time.

The YMCA location affords many amenities such as state of the art classrooms, cafeteria, gym and swimming pool. Y Preschool develops physical, emotional and social competencies, providing more learning opportunities for your child than any other preschool program.

### **ENRICHMENT ACTIVITIES**

The YMCA recognizes that children learn in different ways. The full-day format strengthens learning by utilizing the Creative Curriculum and additional enrichment activities round out the academic curriculum. A nutritious breakfast, lunch and snack are provided and children are given quiet or nap time.

#### ***Enrichment Activities Include:***

**Splash:** introduces children to a safe aquatic environment where fun games help them to become comfortable in and around water.

**Kidz Fit:** builds a foundation of healthy habits while having fun. Your child will enjoy learning about the importance of taking care of their bodies, exercise and movement.

**Music and Movement:** explores musical concepts in a variety of ways including singing, dancing, rhythm activities, finger play and musical instruments. These activities help to bridge the connection between music and movement, and develop large and small motor skills, focused listening and self-expression.

*Other activities include computers, multi-cultural studies, arts & crafts, sign language or Spanish lessons.*

## How to Register:

1. Fill out the enrollment form. Ages must be as of September 1st, 2009.
2. A registration fee of \$50.00 **per child** must accompany the registration form before any child can be considered enrolled or be placed on the wait list. *Registration fee is non-refundable.* Return the form to:

3. The first week's tuition is due the week prior to the program start. If it is not received your spot will be forfeited to those on the wait list. During the school year, tuition must be paid by Monday, one week prior to the start of each month or week.
4. Confirmation will be mailed out upon completed registration. Full packet will be mailed by August 1, 2009.
5. **Childcare immunization records, health care summary and permission slips are due on Monday, one week prior to the start of the program. The child will not be allowed to attend unless we have these health forms. This is a state law. The state requires and checks that a physician has signed the health form.**
