3. The first months tuition is due upon registration. If it is not received your spot will be forfeited to those on the wait list. During the school year, tuition must be paid by Monday, one week prior for the start of each month.
4. Confirmation will be mailed out upon completed registration. A full packet will be mailed.
5. **Childcare immunization records and health care summary are due one week prior to the start of the program. The child will not be allowed to attend unless we have these health forms. This is a state law. The state requires and checks that a physician has signed the health form.**
